

# Drug Information Service Bundle v1.22 – Release Note

## About Drug Information Service Bundle (DISB)

The Drug Information Service Bundle is a software that provides a set of restful services to receive information about substances, generics, and branded medicines present in the Common Drug Codes for India (CDCI) released by the National Resource Centre for EHR Standards (NRCeS) at the Centre for Development of Advanced Computing (C-DAC), Pune.

The software can be useful in receiving additional reference/knowledge about the drugs in various usage scenarios.

The DISB enables clinicians, pharmacists, and researchers to find out relevant information about medicines and substances. It can also help health IT implementors in building decision support systems that can generate alerts about adverse reactions and allergies of medication. DISB will be distributed in synchronization with CDCI. The salient features of DISB include:

- Ready to Deploy with minimal configuration
- Comes packaged with embedded application server
- Easy to integrate REST API with JSON response objects
